The first quarter of 2017 provided numerous opportunities to research, investigate, and spread awareness about North Korean human rights issues. We discussed North Korean human rights issues in a variety of fora for a total of 27 separate events. HRNK has published and spoken at various events in honor of International Women's Day to specifically focus on the increased repression of women in North Korea. Media outlets, including BBC, CNN, The Washington Post, Voice of America, Radio Free Asia, KBS, and Yonhap News Agency, prominently featured our work. Our friends' and supporters' continued commitment to investigating and revealing the truth about the North Korean human rights situation has been reinforced in the past three months. HRNK welcomes our new Board member, Ambassador Robert King, former Special Envoy for North Korean Human Rights. The Honorable Robert King joined HRNK's Board of Directors on April 7, 2017.

#### Ambassador Robert King



The Honorable Robert King was the Special Envoy for North Korean Human Rights Issues from November 2009, following confirmation by the United States Senate, until January 2017.

Prior to his appointment, Ambassador King worked on Capitol Hill for 25 years—24 of those years as Chief of Staff to Congressman Tom Lantos (D-California).

He was concurrently Staff Director of the Foreign Affairs Committee of the U. S. House of Representatives (2007–2008), Democratic Staff Director of the Committee (2001–2007) and held various professional staff positions on the Committee since 1993. Ambassador King holds a Ph.D. in International Relations from the Fletcher School of Law and Diplomacy, Tufts University. He has authored five books and more than 40 articles on international relations

HRNK also welcomes the new member of our International Advisory Council (HRNK IAC), Ms. Sonja Biserko. Ms. Biserko joined HRNK IAC on April 7, 2017.

#### Sonja Biserko



Sonja Biserko was a Commissioner of the UN Commission of Inquiry on Human Rights in the DPRK from 2013 to 2014. Until March 2017, the UN Human Rights Council designated her to be one of two independent experts in support of the work of the UN Special Rapporteur on the situation of human rights in the DPRK to focus on issues of accountability for human rights violations in that country. She is the founder and president of the Helsinki Committee for Human Rights in Serbia. She

has written extensively on the wars in the former Yugoslavia and war crimes including the Srebrenica genocide, the fall of Vukovar, and accounts of the trials of Slobodan Milosevic and Vojislav Seselj. She is the founding member of the Centre for Anti-War Action in the Belgrade Forum for International Relations. She is also a senior fellow of the United States Institute of Peace. In 1994, she received the Human Rights Award of the Lawyers Committee for Human Rights in New York. In 2005, she was one of 1,000 women in the group 1,000 Women for Peace nominated for the Nobel Peace Prize. Ms. Biserko was awarded the 2009 Human Rights Prize of the City of Weimar (Germany) jointly with Jestina Mukoko. In 2010, she was awarded the Human Rights Award of the University of Oslo. She holds her degree from the University of Belgrade Faculty of Economics.

#### **English Media**

From January 2017 to March 2017, HRNK was featured in a total of 55 news articles in English language media. News agencies featuring HRNK included CNN, Forbes, South China Morning Post, Radio Free Asia, KBS World Radio, Yonhap News, The Christian Post, and BBC. Here are a few highlights from the first quarter of 2017:

- On January 16, 2017, CNN reported on North Korea's response to the US State Department's "Report on Serious Human Rights Abuses in North Korea" via KCNA. The article cited HRNK satellite imagery that corroborated allegations of North Korea's prison camp system. This story was picked up and relayed by Yahoo! News, WCYB, KXLV, and Mogaz News.
- On January 25, 2017, Forbes quoted HRNK's publication, "Gulag, Inc.: The Use of Forced Labor in North Korea's Export Industries" by Kim Kwang-jin, leading to reporting by The Christian Post.
- On February 13, 2017, Kim Jong-nam, Kim Jong-un's half brother, was assassinated in Kuala Lampur, Malaysia. This high-level assassination sparked global media attention. HRNK Executive Director Greg Scarlatoiu was interviewed by BBC, BBC Radio, CNN, and the Washington Free Beacon to share his analysis on the implications of this event.
- On March 14, 2017, HRNK was featured in a Foreign Policy article discussing the response to a letter that was sent to urge Secretary of State Tillerson to continue the U.S. leadership role in the UN Human Rights Council. The story was picked up and relayed by Herald Net, Chicago Tribune, i24News, The Republic, Boston Globe, Akron Beacon Journal, WRAL, AP, The Seattle Times, The Spokesman-Review, Jamaica Observer, Free Malaysia Today, The Tower, and Arab News.

#### Korean Media

From January 2017 to March 2017, HRNK was featured in a total of 80 news articles in Korean language media. ### Korea Club with Colonel Ashton Ormes (USA Ret.) in Vienna, VA (March 9, 2017)

On Thursday, March 9, 2017, HRNK and KEI hosted the Korea Club with Colonel Ashton Ormes, who gave a presentation entitled "North Korea and the Mission to Account for America's Missing Korean War Servicemen." Colonel Ormes is a retired U.S. Army Colonel, a Northeast Asia Foreign Area Officer, and a former civilian member of the Defense Prisoner of War/Missing personnel office (DPMO). He first became involved in the mission to account for America's missing Korean War servicemen, and initiatives to win North Korean cooperation in this effort, while serving in the United Nations Command component of the Military Armistice Commission (UNCMAC) in Panmunjom, Korea from 1986 to 1988. In 1995, Colonel Ormes continued serving as UNCMAC Secretary and played an important role in negotiations leading to joint US/DPRK operations in North Korea that went from 1996 to 2005. At the Korea Club, he shared his first-hand experiences in cooperating with North Korean agents to recover the bodies of U.S. soldiers.
